Application is hereby made to Hamilton Southeastern Utilities, Inc. ("Company") for connection of sewage disposal services to be provided at the premises indicated above. Applicant agrees:

- a) to be responsible and pay for all sewage disposal services furnished on the above-mentioned premises until the expiration of seventy-two (72) hours' notice has been duly given at the office of the Company to discontinue the provision of services;
- b) that the meter furnished by the Company (if one is furnished) is, and shall remain, the property of the Company, and the Company's agents shall have access to the meter at all times to read, repair, lock off, seal or remove the same;
- c) that the Company's agents shall have access to any meter, pipes and other appurtenances at all times, for any purpose necessary to render service or to stop the supply of service for the non-payment of bills, when due, for sewage disposal services furnished to the Applicant at said premises, or elsewhere, or for any other lawful cause or purpose which the Company may deem sufficient and said agents are hereby authorized to enter the premises of the Applicant, at all times, for any such lawful cause or purpose or for the purpose of disconnecting or adjusting any meter or appurtenances, or for the purpose of removing any meter or any other connections, or any other property belonging to the Company, but nothing herein contained shall mean, or be construed to mean, that the Company shall be required to inspect or examine, or in any wise be responsible for the condition of the pipes or appurtenances on Applicant's premises;
- d) without limiting the generality of Rules 84 and 85 of the <u>Company's Rules and Regulations</u>, to hold harmless the Company and its affiliates, directors, shareholders, officers, employees, agents and contractors against any liability to any person for injuries, damages, costs and expenses arising from, or caused by, in whole or in part, the back-up of sewage in Applicant's service pipe or on Applicant's premises, unless such back-up is a direct result of the Company's gross negligence or willful misconduct;
- e) to the terms and conditions of the <u>Company's Rules and Regulations</u>, which have been approved by the Indiana Utility Regulatory Commission, and which are on file in the offices of the Commission and the office of the Company;
- f) that storm water (*i.e.* downspouts, sump pump, surface water drainage, etc.) shall not enter the sanitary sewers; and that no connections to sewer mains will be made without inspection and approval of Hamilton Southeastern Utilities, Inc.
- g) to pay all tariffs and charges for service provided by the Company. I understand the Company's current monthly user fee is per equivalent dwelling unit ("EDU") and is set by the most recent HSE tariff available on the HSE website (<u>HSEutilities.com</u>). Service will commence upon the effective date of this agreement as stated above.
